**1. BY MAIL:**

Enclose Treasurer's Copy A/B coupon and check for the amount due with state parcel number on your check.

Payments made by mail **must be postmarked no later than due date**. Payments may be made by: cash, personal check, cashier's check and money order. **When paying by Check please provide Primary Telephone Number.**

**Exemptions:**

If you are no longer eligible for a deduction that you have been allowed in the exemption block of the comparison tax statement, you must notify the County Auditor. Failure to do so will make you liable for taxes and penalties on the amount deducted.

**NOTICE:**

**This Tax Statement is the ONLY notice you will receive for payments of Spring (A) and Fall (B) installments.** Failure to receive a tax statement by mail does not relieve the taxpayer of the responsibility for payment and penalties when delinquent. It is your job to make sure your address is current and up to date.

**IF THERE ARE NO PRIOR DELINQUENCIES, A FIVE PERCENT (5%) PENALTY WILL BE ADDED IF THE INSTALLMENT OF THE TAX BILL IS PAID WITHIN THIRTY (30) CALENDAR DAYS AFTER THE DUE DATE. A TEN PERCENT (10%) PENALTY WILL BE ADDED IF AN INSTALLMENT OF THE TAX BILL IS NOT PAID WITHIN THIRTY (30) CALENDAR DAYS AFTER THE DUE DATE OR THERE ARE PRIOR DELINQUENCIES. NOTICE: THIS TAX BILL IS THE ONLY NOTICE YOU WILL RECEIVE FOR PAYMENT OF BOTH INSTALLMENTS FOR YOUR 2014 PAY 2015 TAXES. PLEASE NOTE THAT FOR MOBILE HOMES, THIS BILL REFLECTS TAXES ASSESSED AND DUE IN 2015.**

- Our credit card processor charges a convenience fee of 2.49% of your total tax payment, minimum of \$1.50. This fee will be charged to your card in addition to the tax payment amount.
